

## **Important Dates for The „Certificate of Studies in European, Comparative and International Law“ Summer Semester 2019**

### **I. Dates applying to students who are working towards a CECIL Certificate (Minor or Major):**

#### **1. Application Period:**

The application period for the CECIL Certificate Programme runs from **24<sup>th</sup> April until 23<sup>rd</sup> May 2019**. Please submit your application with all Required documentation to the International Office of the Faculty of Law (JUR 225, Mondays, Tuesdays, from 7:00 a.m. until 1:30 p.m. and Thursdays from 7:00 a.m. until 12:30 a.m.) during this period.

#### **2. Legal Skills Course Registration:**

The registration period for the Legal Skills courses “Academic Legal Writing” and “Legal Presentation Skills” on StudIP runs from **24<sup>th</sup> April until 30<sup>th</sup> June**.

PLEASE NOTE: The number of available spots in the Legal Skills courses is limited to 20 students. Registrations on StudIP will be accepted for the first 20 students registering on a first-come, first-serve basis. Subsequent registrations will be delegated to a wait-list on StudIP. You can check the status of the waiting list under the course title on StudIP at any time. Should one of the first 20 registrations be cancelled, the first registration on the wait-list will automatically move up to the course list. If you are on the wait-list, please check the registration list of your desired course regularly in order to determine whether you have moved up into the course.

Dates for “Academic Legal Writing”: **Saturday, 22<sup>nd</sup> June 2019 and Sunday, 23<sup>rd</sup> June 2019, 9:00 a.m until 4:30 p.m. in room JUR 328**

Dates for “Legal Presentation Skills”: **Saturday, 6<sup>th</sup> July 2019 and Sunday, 7<sup>th</sup> July 2019, 9:00 a.m until 4:30 p.m, in room JUR 328**

### **II. Dates applying to ALL students who are taking CECIL courses (regardless of whether they are working towards a CECIL Certificate or not):**

#### **1. CECIL Exam Registration Period:**

The CECIL exam registration period on HISQIS runs from **2<sup>nd</sup> May until 31 May 2019**.

Please do not forget to delete registrations for courses that you no longer wish to take an exam in. If you fail to do so, the course will be assessed with “0” points or with a “fail”.

#### **2. CECIL Exam Dates:**

The CECIL exams will most likely (this can be subject to change) take place on **Monday, 29<sup>th</sup> July and Tuesday, 30<sup>th</sup> July 2019**.
