The „Certificate of Studies in European, Comparative and International Law“
Winter Semester 2018/2019**

**I. Dates applying to students who are working towards a CECIL Certificate
(Minor or Major):**

1. Application Period:

The application period for the CECIL Certificate Programme runs from **15th October until 30th November 2018**. Please submit your application with all required documentation to the International Office of the Faculty of Law (JUR 225, Mondays through Thursdays from 7.30 a.m.-12.30 p.m.) during this period.

2. Legal Skills Course Registration:

The registration period for the Legal Skills courses “Academic Legal Writing” and “Legal Presentation Skills” on StudIP runs from **15th October until 4th January**.

PLEASE NOTE: The number of available spots in the Legal Skills courses is limited to 20 students. Registrations on StudIP will be accepted for the first 20 students registering on a first-come, first-serve basis. Subsequent registrations will be delegated to a wait-list on StudIP. You can check the status of the waiting list under the course title on StudIP at any time. Should one of the first 20 registrations be cancelled, the first registration on the wait-list will automatically move up to the course list. If you are on the wait-list, please check the registration list of your desired course regularly in order to determine whether you have moved up into the course. The Winter Semester 2018/2019 will be the first semester during which the Legal Skills courses are being offered by the Faculty of Law and no longer by the Centre for Career and Competencies.

**II. Dates applying to ALL students who are taking CECIL courses
(regardless of whether they are working towards a CECIL Certificate or not):**

1. CECIL Exam Registration Period:

The CECIL exam registration period on HISQIS runs from **2nd November until 30 November 2019**.

Please do not forget to delete registrations for courses that you no longer wish to take an exam in. If you fail to do so, the course will be assessed with “0” points or with a “fail”.

2. CECIL Exam Dates:

The CECIL exams will take place on **Monday, 11th February and Tuesday, 12th February 2019**.

PLEASE NOTE: The exam for “A Comparative Introduction to German Law” will take place on 14th January 2019, 4:00-6:00 p.m. in Seminar Room (JUR) 147a.
