**I. Dates applying to students who are working towards a CECIL Certificate (Minor or Major):**

**1. Application:**

Please send an **e-mail** to [ulrike.wassermann@uni-passau.de](mailto:ulrike.wassermann@uni-passau.de) and indicate which certificate you would like to acquire (CECIL Minor or CECIL Major). Please attach the following documents to this e-mail:

- **proof of your enrolment at the Law Faculty of the University of Passau,**
- **copies of your diploma and certificates relating to your previous studies,**
  - if you are an international student, proof that you have studied law for two years at your home university,
  - if you are a German student, proof that you have passed your “Zwischenprüfung”,
- **and proof of your Level B2 English language proficiency.**

**2. Legal Skills Course Registration:**

The registration period for the Legal Skills courses “Academic Legal Writing” and “Legal Presentation Skills” on StudIP runs from **15<sup>th</sup> until 25<sup>th</sup> April 2024.**

**PLEASE NOTE:** The number of available spots in the Legal Skills courses is limited to 20 students. Registrations on StudIP will be accepted for the first 20 students registering on a first-come, first-serve basis. Subsequent registrations will be delegated to a wait-list on StudIP. You can check the status of the waiting list under the course title on StudIP at any time. Should one of the first 20 registrations be cancelled, the first registration on the wait-list will automatically move up to the course list. If you are on the wait-list, please check the registration list of your desired course regularly in order to determine whether you have moved up into the course.

**And please don't forget to cancel your registration if you don't want to attend the seminar. Otherwise you'll block a spot unnecessarily!**

**II. Dates applying to ALL students who are taking CECIL courses (regardless of whether they are working towards a CECIL Certificate or not):**

**1. CECIL Exam Registration Period:**

The CECIL exam registration period on “Campus Portal” runs from **21<sup>st</sup> May 2024** **until 17<sup>th</sup> June 2024.**

Please do not forget to delete registrations for courses that you no longer wish to take an exam in. If you fail to do so, the course will be assessed with “0” points or with a “fail”. **Withdrawal** from the examination registration is possible until **1<sup>st</sup> July 2024** at the latest.

**Please note that there can be other (earlier) deadlines for a few CECIL examinations! Therefore please contact the course convenor and/or StudIP for more information!**

**2. CECIL Exam Dates:**

The CECIL exams will most likely (this can be subject to change) take place on **Friday, 19<sup>th</sup> and Saturday, 20<sup>th</sup> July 2024.** Please note that this are the days after the end of the lecture period! So make sure you will still be in Passau at that time!
