I. Dates applying to students who are working towards a CECIL Certificate (Minor or Major):

#### 1. Application Period:

Please send an <u>e-mail</u> to <u>ulrike.wassermann@uni-passau.de</u> <u>by the 15<sup>th</sup> November</u> <u>2021</u> and indicate which certificate you would like to acquire (<u>CECIL Minor or CECIL Major</u>). Please attach the following documents to this e-mail:

- proof of your enrolment at the Law Faculty of the University of Passau,
- copies of your diploma and certificates relating to your previous studies,
  - o if you are an international student, proof that you have studied law for two years at your home university.
  - if you are a German student, proof that you have passed your "Zwischenprüfung",
- and proof of your Level B2 English language proficiency.

#### 2. Legal Skills Course Registration:

The registration period for the Legal Skills courses "Academic Legal Writing" and "Legal Presentation Skills" on StudlP runs from 19<sup>th</sup> November 2021 until 6<sup>th</sup> January 2022.

**PLEASE NOTE:** The number of available spots in the Legal Skills courses is limited to 20 students. Registrations on StudIP will be accepted for the first 20 students registering on a first-come, first-serve basis. Subsequent registrations will be delegated to a wait-list on StudIP. You can check the status of the waiting list under the course title on StudIP at any time. Should one of the first 20 registrations be cancelled, the first registration on the wait-list will automatically move up to the course list. If you are on the wait-list, please check the registration list of your desired course regularly in order to determine whether you have moved up into the course.
