- You will not be able to register in this way if there is still an open registration from the previous semester. If this is the case, please contact the respective chair directly so that the open registration can be booked.

- You must **generally register** for all exams you intend to sit in a given semester during the registration period. You will not be allowed to sit an exam for which you have not registered.

- Check the relevant chairs' websites to see if there are any additional registration modalities.

Notes on resits during a leave semester:

- During your leave semester, you may **only resit exams you have previously failed**.
- **You cannot resit passed exams for mark improvement during a leave semester.**
